Membership Categories –

- **Professional Member – (BAOT/COT Member)** - To be eligible for this membership you should be a registered BAOT/COT member. This includes full and part-time members. (Excludes overseas members who receive correspondence by air mail). **You must quote your BAOT number to receive membership at this price.**
- **Student Member**- This category includes all students who are undergoing a course within the United Kingdom and approved by Council, leading to a recognised occupational therapy degree.
- **Associate Member** - (Technical Instructor, OT Assistant/Helper, classroom support assistants, personal carers, etc.)This category is for members who are not eligible for HPC registration but are supervised by an occupational therapist that is eligible for professional membership.
- **College / Library**: For all libraries of OT training establishments to receive 2 copies of newsletter etc.
- **Overseas Membership** - This is for members who are not resident within the UK. They may be an occupational therapist or from another profession.
- **Other Professional in UK** - This category is for any occupational therapist who is not a BAOT/COT member, or any professional member of another discipline who has an interest in people with learning disabilities
